# 3. Approval of Minutes - November 16, 2022 Board Meeting

Capt. Wurpes moved and Chief Schmerber seconded. Motion passed unanimously.

# **Executive Committee – Chief Jorge Tro:**

• Project Budget Update: Same info under financial report

# **Technical Committee - Ron Polluconi:**

 Did not meet this month. Going to expand the scope of the meeting to include all 4 of the MAJCS PSAP's. This should help cover more questions that may not get asked with the current group

# Citizen Accountability - Chief Don Johnson:

- Chief Johnson sent out an overview of where they are, and how they have tried to trim the budget down. Chief Johnson added that it would be a good idea to keep them informed all the way through
- He has invited Dave Austin to join the budget group to help build so that this never happens again. Ideally there would be a financial person that would rotate through every couple of years

#### 6. Communications: None.

### 7. Financial Report – November / December 2022 – Mark Buchholz

- Mark reviewed the agency payment estimates and the original overage estimate of \$4.7M. The ARPA funds have been added to the spreadsheet, however those are yet to be finalized
- o Also in process is the Motorola credit of \$308k
- We did lock in an agreement with the BOLI claim for 25%, which is reflected on the financial report. Chief Tro reminded the group that Motorola had asked C800 to pay 50% of the claim, however Mark was able to negotiate this down to 25%
  - Chief Band asked what are the odds of all of these come to fruition, and when would the users be expected to pay. Mark stated that the agencies should plan to pay these in the next fiscal year
    - We are still waiting to hear from the county about the ARPA funding, and to confirm that the money spent will pass all of the criteria
    - Also still working on the Columbia equipment sale
    - Chief Tro clarified that the blue far right column is the best estimate with the various credits applied (Columbia 911 sale, ARPA, Motorola credit). Use this as your estimate for budgeting
    - It is going to take some time to finalize the figures, most likely into next year before everything is settled
    - Chief Tro noted that the original anticipated cost was \$4.8M and there has been a lot of work to get this cost lowered, which is very much appreciated

### 8. Old Business:

# System Management - Ron Polluconi

- Radio Use Issues
  - Wrapped up a little over 90% of the Whalehead site, and is now fully stabilized
  - Oak Grove Butte is at a standstill due to large amount of snow that has fallen, work will resume in the spring
- Home Button Reprogramming
  - Wrapping up mid-march. Just smaller agencies still needing to complete
  - There will be a blackout period as they move from the old WCCCA site to the new.
     They will be switching the redundant system and anticipate about a one week outage
- Streaming Delay
  - Looking at an alternate service provider that can better meet our needs
    - Capt. Wurpes asked do we really want to stream at all. He noted several agencies that aren't doing it at all due to safety issues
    - Sue noted that LOCOM is also not streaming due to too many unknowns
    - Capt. Wurpes added that we have been working on this for a while, and have yet to get it to work properly
    - Ron noted that it can be switched on and off at any time
    - Ron also added that the media seems content hearing the Sheriff's office on the 2 primary channels. Capt. Wurpes asked if there are delays for the other agencies that have decided to stream. Ron noted that they are sometimes delayed

- Ron let the group know that most of the law agencies typically pick their primary dispatch to stream
- Portland is a good point of reference when they first started with the unrest they were not encrypted. They have since chosen to move over to all of their encrypted channels and have not moved back
- There are a lot of scanner enthusiasts that Ron hears from on a regular basis when we stop streaming. Generally there are between 30-109 people listening at any one time
- Capt. Wurpes thanked Ron for his help on this
- Add this to new business for discussion at the Feb Meeting
- Eric Kennedy noted that it would be useful to know what the ongoing costs would be to maintain this service
  - Ron sated that he believe the package we currently have is \$63/year
- Our two partners are not reliable, looking at buying the hardware ourselves
- 800 MHz Voice Paging
  - o Paging servers are shipping tomorrow, looking at a mid-Feb. timeframe
  - Will also be replacing a 35 year old paging system that we have today

# **System Upgrade/Replacement**

### **DVRS** – repeaters – Ron Polluconi:

- Got the attention of Futurecom for the purchase/acquisition by Motorola. We have provided them with frequencies for the DVR's
- Portable radios will need to be upgraded with the DVR option. There is some cost and time delays associated with this

# 9. New Business (\*Action Item)

- Election of a 2<sup>nd</sup> Vice Chair
  - o Chief Johnson nominated DC Carlsen from CFD1
  - o Chief Corless moved to accept the nomination of DC Carlsen for 2<sup>nd</sup> Vice Chair
  - Chief Band Second the motion
  - Motion carried

  - o Looking to create a budget committee
  - It is important that all members of C800 that wish to participate in the budget committee, are welcome. Also, each agency may select a citizen representative or other finance personnel. Please identify who your rep will be by Feb. 10<sup>th</sup>
  - Need to officially appoint who will serve on the Budget Committee, which will allow us to identify the number of members for a quorum. We will officially appoint the Budget Committee at the next C800 Board meeting
  - Capt. Wurpes made a motion to appoint Mark Buchholz as the Budget Officer. Chief Corless seconded. Motion carried
  - Chief Johnson restated that you don't have to appoint someone to the committee, but may if you like. The Eboard will all serve on the committee at a minimum
  - Looking to officially adopt the budget at the June Board meeting, then submit to the
     State by June 30
