3. Approval of Minutes - May 17, 2023 Board Meeting

Chief Davis moved and Chief Tro seconded. Motion passed unanimously.

4. Public Comment: Chief Don Johnson None.

5. Communications: Mark Buchholz

6. Accept Financial Report for May 2023: Mark Buchholz

- Mark pointed out under the Misc. Expenses that a number of charges showed up as EFT withdrawals that ended up being fraudulent. There were a total of 11 transactions over the 15 day period for a total amount of \$13,812. We were told by the Bank that because we are a business account, they would only respond to transactions made in the last 24 hours, therefore there is nothing they will do about them
- Chief Mahuna Clackamas SO to investigate and they recused themselves as they felt that they were victims as well. He also contacted OSP, who declined, so West Linn has begun an investigation
- As far as insurance, this type of fraud does not apply under FDIC. At this moment it appears it will be a loss

- This is the 2nd or 3rd time we've had issues with Clackamas County Bank, so the Eboard has decided to move all C800 funds to another financial institution and to explore additional fraud protection options.
- Already have this methodology set up at WCCCA, so they are familiar with this style of banking. This should be done next week
- Motion to approve the financial report as presented was made by Chief Corless and seconded by Chief Mahuna. Motion carries unanimously

7. Committee Reports

Executive Committee: Chief Don Johnson

 Has a meeting set up with WCCCA to work through an audit on the vendor billings, with potential double billings

Technical Committee: Ron Polluconi

• Met and covered issues related to dispatch and CAD issues. There were no action items

Citizen Accountability: Chief Don Johnson

 Chief Johnson will be sending out a note following this meeting letting them know where we are with various issues

8. Old Business

- Radio System Management: Ron Polluconi
 - i. Remaining site construction update
 - Little work left on 224 site gate refurbish, road work
 - TDH site walk is happening tomorrow morning with USFS and a new trainee.
 Looking at relocation of the tower. Have figured out that the ski area had been directing the contractor directly which caused some discontent and has resulted in some design changes
 - ii. Radio Use Issues
 - Nothing has been reported
 - iii. Home Button Reprograming
 - This process has stopped and transitioning into maintenance
 - The first who received radios will be the first to be offered an opportunity for
 preventative maintenance. They will have the option to move forward, or they
 can defer at which time they would be placed back into the rotation
 - There are a couple of variances in this maintenance cycling. For fire users, we
 would normally come to the location and go through all of the equipment.
 With law enforcement, they would generally set up in the service yard
 - Another option is that WCCCA does have a large service bay where they can queue up vehicles and do a mass programming on site
 - The team also does have access to more mobility as they have test equipment that they can set up outdoors, they would just need support for power

iv. Streaming Delay

 Withheld payment and notified management that until this is completed we will not be making further payment. This got the CFO's attention, which was

- then pushed back to engineering. We now have an active engineering process underway
- Once the testing has been completed and approved, they will build streaming controls and an actual delay process into that interface. We do not have a hard date at this time, but we do have a hard start that engineering has begun

v. 800 Voice Paging

- Equipment is in place, new paging system has cut over. A few issues with the cutover, they had to manually enter all of the CAP codes for all of the paging and a couple imports did not occur correctly
- If anyone has issues with station alerting backup, please let Ron know ASAP

vi. DVRS Update

- Ready to go for evaluation. Lake Oswego's first command vehicle has been updated and they are testing the vehicle today. Ready to start evaluation with other agencies
- 1 DVR, 1 vehicle with 4 portable radios for evaluation. Once evaluations are completed and FDB approves, they will release the programming and load it into the preventative maintenance and catch them as they go through

9. New Business

- Second Vice-Chair: Replace Michael Carlsen (CCFD1) who recently retired with Assistant Chief Brian Stewart (CCFD1)
- Adopt FY24 Budget
 - i. Mark discussed the information presented in the meeting packet
 - ii. Some changes of note:
 - Corrected the fund balance as highlighted in the packet
 - Actual audited numbers were input for FY 22
 - Site Rental was updated
 - Eric Kennedy asked if the proposed beginning fund balance assume full payment of the shared costs that we are distributing for the shortfall
 - No, the beginning fund balance does not assume that, it's listed as
 additional revenue. When this comes in, the \$1.14M will be enough to
 bring us back to positive
 - Toby LaFrance asked with the ending fund balance, do we have a breakout of how much is going to be available vs. pre-paid
 - Mark explained that he will need to look into this as he didn't have those numbers accessible at this time
 - Toby LaFrance asked if Mark could explain the greyed out column of the approved budget
 - Mark greyed out that column as it was the first version that the committee focuses on and approved. This info. is what was projected based on what we knew prior to the audit. The audit was finished in May, so we knew exactly where the funds were and could update accurately
 - iii. Mark discussed the resolution and its components illustrating that this is the total of the capital item and the total of the materials and services, as well as outlined the spending authority. Motion was made to adopt the resolution as presented by Chief Mahuna and was seconded by Chief Tro. Motion carries unanimously
