**2.22 NOTICE OF INTENT TO AWARD:**

- a. Notice. At least seven calendar days before the Award of a Construction Purchase Order, C800/WCCCA shall issue to each Bidder (pursuant to ORS 279C.375(2)), or post electronically or otherwise, a notice of C800/WCCCA's intent to Award the Contract.
- b. Form and Manner of Posting. The form and manner of posting notice shall conform to customary practices within C800/WCCCA's procurement system, and may be made electronically.
- c. Finalizing Award. C800/WCCCA's Award shall not be final until the later of the following:
  - i. Seven Calendar Days after the date of the notice, unless the Solicitation Document provided a different period for protest; or
  - ii. C800/WCCCA provides a Written response to all timely-filed protests that denies the protest and affirms the Award.

Prior Notice Impractical. Posting of notice of intent to award shall not be required when C800/WCCCA determines that it is impractical due to unusual time constraints in making prompt Award for its immediate procurement needs, documents the Contract file as to the reasons for that determination, and posts notice of that action as soon as reasonably practical.
