Re: Encryption Capable Radios

Chief Charlton advised that he had met with Washington County Fire Defense Board Thursday August 25th and they advised that they are going to have encryption capable radios, but it was unclear if they are going to encrypt any channels.

Chief Charlton requested that I do a cost estimate for current / future radios in the C800 system that will need to be encryption capable? Further he asked if we can dedicate a portion of the \$5 million to cover the cost of the upgrades or will there be other funds available in the \$59 million GO Bonds?

According to our latest inventory Partners have 653 A series radios. Some of these radios are encryption capable but at the moment I am not sure how many. The project budget includes funds to upgrade these existing radios to encrypted capable at an estimated cost of \$255,000.

Partners have 1,435 non A series radios that need to be replaced by 2018. It is recommended that all radios be encryption capable. The cost for encryption at the December 2015 purchase was \$308 per radio. It is anticipated that cost may be lower when we make the next group purchase due to higher volume. Based on the sale of the bonds we may have some premium dollars available that could be added to the \$5millon set aside for purchase of subscriber radios to cover this cost.

Members have 57 A series radios and 86 non A series radios.

Mutual Aid affiliates have 23 A series radios and 25 non A series radios

CCOM/LOCOM have 16 A series radios and 162 non A series radios. These are primarily cache radios and they will need to be updated and project funds have been anticipated for this upgrade.

Re: Approval of Project Management Agreement

REQUEST: It is hereby requested that the C800 Board of Directors authorize entering into a personnel services contract in an amount not to exceed \$350,000 with a firm to provide project management services for the Radio Upgrade Project. Details of the recommended firm will be provided at the September 14, 2016 Board meeting.

ISSUE: As part of the Radio Upgrade Project the services of an independent Project Management firm have been included in the project planning and budgeting for the project. The Project Management firm will provide appropriate personnel to provide project oversight with key responsibility for schedule and budget management.

C800/WCCCA published a Request for Proposal for Project Management Services on May 26, 2016 and received twelve requests for the document and four proposals on June 23, 2016. The purpose of the Request for Proposals (Solicitation) was to obtain competitive offers from qualified Firms or Individuals interested in providing WCCCA/C800 with Communication System Upgrade Project Management Services.

SCOPE OF WORK:

The Provider shall provide organizational skills, management oversight, and fiscal control in an expeditious and economical manner consistent with the interests of the overall project. The Provider's primary responsibility is managing the successful implementation of all key project elements of the Communications System Replacement Project and will include but are not limited to the following:

- i. Communications site acquisition, development, construction and provisioning in compliance with the most current Motorola R56 Standards and Guidelines for Communications Sites.
- ii. Upgrading existing communications sites to comply with new design needs and or regulatory or land use requirements. (R56 compliant upgrades, essential facilities, tower loading and or related revisions)
- iii. AC power generation and DC power and backup systems.
- iv. Microwave backhaul systems (IP and TDM technologies)
- v. Network management systems, security, telemetry, alarms and surveillance
- vi. Wireless Ethernet connectivity to key public safety facilities (IP underlay)
- vii. P25 Land Mobile Radio subscriber equipment receipt, inventory control, programming/upgrades, distribution and installation as appropriate.

- viii. P25 Land Mobile Radio infrastructure scope of work (SOW) acceptance testing, shipping, installation, startup, optimization, systems performance and system coverage testing.
- ix. P25 Land Mobile Radio subscriber cut over and final acceptance testing/approval.
- x. Directly purchased and or supplier provided equipment inventories and reconciliation.

The four firms that provided proposals were;

- 1. Plan B Consultancy Lake Oswego, OR
- 2. 3dB Communications Beaverton, OR
- 3. Gillespie, Prudhon & Assoc Clackamas, OR
- 4. Compass Project Solutions Keizer, OR

A four-person review team evaluated the proposals based on the criteria outlined in the RFP document and narrowed the field to Plan B Consultancy and 3dB Communications. Interviews are being conducted on August 8th to determine a finalist for recommendation to the Board.

FINANCE: The funds are budgeted as part of the Radio Project.

LEGAL: A C800 professional services contract as approved by legal counsel will be utilized.

RECOMMENDATION: It is recommended that the C800 Board of Directors authorize entering into a personnel services contract in an amount not to exceed \$350,000 with a firm to provide project management services for the Radio Upgrade Project. Details of the recommended firm will be provided at the September 14, 2016 Board meeting.
