Re: Award of Contract for Sawtell Construction to HPS Construction

REQUEST: It is hereby requested that the C800 Board of Directors approve entering into a lump contract in the amount of \$169,00 with HPS Construction Cornelius, Oregon for the construction of the Sawtell site.

CONTRACT DESCRIPTION: Cushing and Associated prepared bid documents for the construction of the Sawtell radio site which were issued for competitive bid in accordance with C800's purchasing rules on February 24, 2016. Bids were received on March 23, 2016 from five bidders all of which were responsible and responsive. The budget for the scope of work was \$238,000. The low bid was \$169,000 and high bid was \$268,153. The low bidder was HPS Construction of Cornelius, Oregon and is fully compliant to the bid process. A seven-day notice of award was issued on March 25, 2106 and no protests were received. Plans are at the County for permit. I anticipate a May 2, 2016 start of construction.

FINANCE: The funds are budgeted in capital outlay. It is anticipated that the cost will be reimbursed by the future radio system replacement general obligation bond.

LEGAL: A C800 construction contract will be utilized as approved by legal counsel.

RECOMMENDATION: It is recommended that the C800 Board of Directors approve entering into a lump contract in the amount of \$169,00 with HPS Construction Cornelius, Oregon for the construction of the Sawtell site.
